The MCA has designated the Insolvency and Bankruptcy Board of India (IBBI) as the authority for implementing the new regime of Registered Valuers apart from insolvency resolution professionals That MCA stipulates any valuation assignment after 31st Jan 2019 is to be done by a register valuer only




